NINUTES

The 1st Meeting of the 32nd Legislative Session was called to order at 6:45pm. A sign-in for roll call was passed around. Senator Strong objected to the Agenda and said to have Bill 1 put on Special Orders. There was another objection to the Agenda and to add election to President Pro-Tempore before Executive Reports. It was all approved and so was the minutes.

There was a nomination for Chris Strong to be elected as President Pro-Tempore. Hearing none, nine senators approved Strong as the newly elected Pro-Tempore.

EXECUTIVE REPORTS

Chris Brodt asked Jon Moretti to come down to the Senate and swear in the newly elected senators. Brodt congratulated all the new senators and said to ask anyone for help or that questions can be answered by the secretary of SA, or anyone who has been on board for a long time.

A representative from SHRM came forward and spoke about a reimbursement of money for a conference. This annually conference will be taking place on June 22-26. The representative was asking for a reimbursement of \$268.00. The Senate has the decision to allow the reimbursement to follow through; however, the Senate needs authorization to override the ruling. The representative commented on how the secretary of SA was knowledgable of granting the money, but the Director of Finance did not. There was a suggestion made from the body to give them the money; it was not done on purpose and since they are an organization of SA, it would be favorable. There was a motion in favor to give them the money reimbursed; a 10:0:0 was passed. In Bill 1, a \$10,000 amount is sitting in an account (enfranchise programming).

Talked in a previous meeting, TicketMaster was brought up upon discussion. Moving from Movies Plus, the charge to buy the station is \$2300. It would be placed in the Union's check-cashing. Are there benefits and pluses? It will not make any money but will provide a service to the students. Per ticket, it would make perhaps \$0.15 - \$0.20. There would be no ser-charge for campus events (dinners, etc.). This will save money in the long run; Brodt said that if installed, there would be a one year contract

issued. The \$2300 would include the installation of the machine and for the phone line. Mark Nahorny commented that it would not make money but perhaps cost money; you need to proceed with caution with this matter. It is viewed, however, as a programming opportunity. The Senate will not authorize this process. Senator Goldowsky urged not to pass because there needs to be more information found about this procedure. In the end, there was a favor to pursue TicketMaster by a vote of 6:4.

Rachel from NYPIRG announced her last announcement and said that the two new students will be here to run NYPIRG for next year. She wished all a good summer and good luck on finals. Chris Brodt thanked Rachel for all her hard work.

Brodt then wished everyone a safe summer and for next year, there will be changes.

Mark Nahorny said that the Senate is a key partner on this campus and there is a responsibility to attend the meetings and take action. It is a learning experience.

Dean said that there is 300 new transfer students coming in this Saturday. The Seante's work is important; there is a wide spread of representation on this body.

Minutes

The 2nd meeting of the 32nd Legislative Session was called to order at 6:40 pm. A sign in for roll call was passed around. Both the agenda and the minutes were approved.

Executive Reports

President Chris Brodt welcomed the body back. He then proceeded to introduce the members of the executive branch. Howard Gordon from the Presidents' Office was present, and acting as a proxy for Deborah Stanley. He extended Stanleys' apology for not being able to personally attend, and also stressed the fact that there is an open-door policy with the Presidents' Office, and that we should feel free to address our issues and concerns with them.

Mark Nahorney stressed that our whole experience with the Student Association is an experience that we should utilize as an excesize. This is a new situation for many of us, and we should seek out his help, or the help of the SA Executives with problems, concerns, or questions.

President Brodt then introduced: Eric Schwars, intramurals director; Jon Morretti, Chief Justice, Supreme Court; Taryn Breen, his executive assistant; Kristi DiGoia, Lead Center; Steven Woods, Director of Marketing; Keith Washo, OCA director; Nate Garland, NYPIRG Director; and Roy Mirenda for appointment to the SA Supreme Court. Roy stated that the hours of availability to meet him wereTuesday, September 17, 1996, from 3-4 pm.

Next Mr. Brodt gave his state of the Association Address. This entailed the overview of what he has been able to accomplish throughout the summer and the project which are still being negotiated. He stressed the importance of communication throughout the SA and reaching out to the students as awhole to get them involved with the various programs that the SA sponsors. He further stated that we need to keep in mind the importance of attending the meetings and that suggestions are always welcome, and we should keep in mind to promote the SA as a whole.

Further he stated that the Corner Store is now bringing in \$400.00 a day, which is a substantial increase in their profits. In closing, he stated that we have many things occurring, and that we need th maximum of participation and promotions.

SA Funds for Non- Discriminatory Speakers Senator Schwartz put the motion before the floor to place this issue on the table for the period of one week, the floor, by a vote of 8 for and 4 against voted to place this Resolution on the table until the September 18th meeting.

Resolution #2;

Commendation for Individuals Involved in Tear Gas Incident Senator Strong placed an amendment on the floor and such amendment passed by general consent. After further debate the Resolution passed also by general conaent of the assembly. Further, it was agreed that Roger H. DeMott would received a copy of the signed resolution. Also, Deborah Stanley is to be in receipt of the signed document.

Public Comments

Senator Gordon remnded the Assembly of the ALANA Conference which is to be held on September 16-21, and urged everyone to attend.

Senator Strong apologized for his slight tardiness, and went on to inform the assembly that the intramural sports program has been improved greatly, and involvement in such has risen dramatically.

Senator Wagner informed the assembly of a Group called NETWORK, which is a Minority Honor Society, which meets at 4-6pm in 213 Hewitt Union.

Moretti once again stated that the assembly should send a copy of Resolution #2 to Roger DeMott. He also informed the assembly that he was constructing a Round Table Discussion Series with WTOP, and would appreciate volunteers to act as guest hosts, hosts, and guests on this program. The program would entail facets such as National and Domestic Concerns. Senators Strong and Wagner volunteered to be involved with this project.

President Brodt informed the assembly of the Womens' Rugby team tie with Cortland State, he also reminded everyone of the upcoming ALANA Conference on September 16-20. He also reminded the assembly of the SA Involvement Fair on September 16th at 10am-3pm in the Hewitt Union Ballroom. He thanked the Lead Center for their cooperation in setting this up.

Senator Goldowsky congratulated the Senators, President Brodt, and the Chair for their return to the assembly, and congratulate the new senators on their placement in the senate. He stressed the importance of attendance, and stressed that our work can only be efficient, and worthwhile if everyone shows the incentive to attend.

Mark Nahorney suggested that a training session should be held to acquaint the assembly with the rules and regulations, and to get to know each other better. He suggested possibly a social.?

Also, he stressed that when we deal with resolution #! we should keep in mind the speech codes and that we are danger-ously close to overstepping boundaries concerning free speech, and prior restraint. He stressed that this resolution should be circulated and to get feedback as to how our constituents feel pertaining to its' content.

He extended an invitation to attend the ALANA Conferences that it is important for us to attend, and to celebrate the diversity of the campus and to welcome the new students to our ranks.

Mike Sloika from Johnson Hall wants to become a Senator andinquired as to how to go about this and that he needs more information and especially assistance.

Senator Strong stated that he felt that Sloika would make a good senator, and further stated that Auxiliary Services has undergone many changes and that to further appease what the students want they need input from the students. IE: how do you like the changes, would you like to see something else on the menus, what do you think of the new meal plans.

He also brought up the issue of the lack of lights on the desks in Onondaga Hall. Can we get something accomplished in the return of lights for the desks? Perhaps we could arrange a meeting with Weeks or Driscoll pertaining to this?

The meeting was called to order at 6:43 pm. Roll call was taken and there were 23 Senators present. The agenda was approved. The minutes were approved after an amendment was to the financial report, and public comments and announcements.

PRESIDENT'S REPORT

-President Brodt asked for a confirmation on the nomination of Jennifer Barber as the supreme court justice and there were no objections.

-Chief Justice addresses the assembly with the seriousness of the case that the Vice President, Elizabeth Linderberry walked out on.
