PREAMBLE

WE, THE STUDENTS OF THE STATE UNIVERSITY OF NEW YORK

COLLEGE AT OSWEGO, IN RECOGNITION OF THE RESPONSIBILITY SHARED

BY THE ADMINISTRATION, THE FACULTY, AND THE STUDENT BODY IN

STUDENT LIFE AND AFFAIRS, HEREBY CONSTITUTE THE STATE UNIVERSITY

OF NEW YORK COLLEGE AT OSWEGO STUDENT ASSOCIATION, BELIEVING

THAT BY ORGANIZING IN THIS WAY WE CAN BEST ACCOMPLISH THE

FOLLOWING PURPOSES: TO SERVE AS THE STUDENT BODY AGENCY IN

THE PRESENTATION OF STUDENT OPINION IN MATTERS AFFECTING

STUDENT LIFE AND AFFAIRS; TO SERVE AS AN APPELLATE AGENCY

FOR PROBLEMS REFERRED TO THE STUDENT ASSOCIATION BY STUDENTS

OR STUDENT ORGANIZATIONS; TO PROMOTE, IN THE INTEREST OF

THE COLLEGE COMMUNITY, A PROGRAM OF SERVICE, SOCIAL ACTIVITY,

AND EDUCATIONAL PROJECTS.

CONSTITUTION OF THE STUDENT ASSOCIATION

OF THE

STATE UNIVERSITY OF NEW YORK COLLEGE AT OSWEGO

ARTICLE I

Section I

All legislative power herein granted shall be vested in the Senate of the Student Association.

Section II

- 1. The Senate shall be composed of members chosen annually by the living center or centers. (The term living center shall be defined in the By-Laws of this constitution.)
- 2. All Senators shall be regularly enrolled students of the State University of New York College at Oswego with an accumulative grade point index of at least the college minimum for good academic standing, and each shall at the time of his election be a member of that living center or of one of those living centers from which he shall be chosen.
- 3. Senators shall be apportioned among the several living centers within the college according to the respective numbers in the living centers.

The enumeration shall be made 30-60 days prior to the All-Campus Election on the basis of estimated membership in each living center for the coming fall semester.

The Senate shall determine the number of Senators to be chosen by each living center or group of living centers. The number of Senators shall never exceed 25 nor be less than 15. No living center shall be denied representation.

- 4. When vacancies occur in the Senate by resignation or otherwise, they shall be immediately filled by Writs of Election issued by the Executive Authorities of the living center or centers affected, and eventually filled by special elections conducted among the residents of such living centers.
- 5. The Vice-President of the Student Association shall be the President of the Senate, but shall have a vote only in the event of a tie.
- 6. The Senate shall choose its other officers, and also a president pro tempore, in the absence of the Vice-President, or when he shall exercise the office of President of the Student Association.
- 7. The Senate shall have the sole power of impeachment and trial of impeachments. In all cases of impeachment the Chief Justice of the Supreme Court shall preside, except in the case of his own impeachment in which case the Vice-President of the Student Association shall preside. No person shall be convicted without the concurrence of 2/3 of the members present.
- 8. Judgement in cases of impeachment shall not extend further then to removal from office, and disqualification to hold and enjoy any office of honor or trust in the Student Association.

Section III

1. Senators may be elected at an open election of the members of their living center or living center group.

2. The Senate shall assemble at least once every full academic week during the college year, except during the weeks of final examinations and the first week of the fall semester.

3. All Senators shall be elected at the time of the All-Campus Election.

Section IV

l. The Senate shall be the judge of the elections, returns, and qualifications of its own members; and a majority shall constitute a quorum to do business. But a smaller number may convene and may be authorized to compel the attendance of absent members under such penalties provided by the Senate.

2. The Senate may determine the rules of its proceedings, discipline its members for disorderly behavior, and with the concurrence of 2/3 is of the total Senate, expel a member.

3. The Senate shall keep a journal of its proceedings, and from time to time publish the same, and the yeas and nays of the Senate on any question shall, at the desire of 1/5 of those present, be entered in the journal.

Section V

No Senator shall, during the time for which he was chosen hold any other civil office under the authority of the Student Association and no person holding any office under the Student Association shall be a member of the Senate during his continuance in office.

Section VI

Every bill which shall have passed the Senate, before it becomes law, shall be presented to the President of the Student Association. If he approves it he shall sign it; but if he returns it with his objections to the Senate, they shall enter the objections in the Journal and proceed to reconsider it. If after such reconsideration 2/3's of the total Senate agrees to pass the bill it shall become law. But in all cases the vote of the Senate shall be determined by yeas, nays, and the names of the persons voting for and against the bill shall be entered in the Journal. If any bill is not returned by the President within 10 regular class days after it has been presented to him, the same shall be law, in like manner as if he had signed it, unless the Senate by its adjournment prevents a return in the form of a veto, in which case it shall not be law.

Section VII

The Senate shall be empowered:

1. To supervise the All-Campus Election;

2. To assess a Student Association tax (This tax shall be uniform throughout the Student Assoc.);

3. To determine the expenditures of the Student Association Tax for the general welfare of the Student Association;

To have authority to make recommendations over all matters of policy affecting student welfare under this constitution;

To determine the line of succession to the office of Student Association President following the Student

Association Vice-President;

To initiate and enact any legislation necessary to implement the foregoing powers or to fulfill the purposes of this constitution as set forth in the preamble except where such jurisdiction shall be denied by the policies of the State University of New York or the State University of New York College at Oswego.

Section VIII

No money shall be drawn from the treasury, but in consequence of appropriations made by law, and a regular statement and account of the receipts and expenditures of all money shall be published from time to time.

The Senate shall pass no law regarding the internal operation of any student organization recognized under the

authority of the Office of the Dean of Students.

Section IX

1. Upon presentation to the Senate of a petition of 25% of the number of voters in the previous All-Campus Election, any bill which they shall deem necessary shall be submitted to the Student Association within 2 weeks after the presentation of the petition to be accepted or rejected; and, if accepted, shall have the same standing as any bill passed by

the Senate and signed by the Student Association President.
2. The Senate may, by 2/3 s vote of the total membership, submit any bill to the Student Association who shall accept or reject it; and if accepted said bill shall have the same standing as any bill passed by the Senate and signed by the Student Association President.

ARTICLE II

Section I

1. The executive power shall be vested in a Student Association President who shall, together with the Student Association Vice-President, be elected by an All-Campus Election at the earliest practicable date during the period from the 15th of March to the 15th of April; and hold office for a term of one year commencing the 1st day of May of the same year.

The President and Vice President shall be regularly enrolled students each with an accumulative grade point index of at least two-tenths of a point (.2) above the college minimum for good academic standing, and shall not be eligible for graduation until the completion of the semester in which their term of office ends. The President at the beginning of

the fall semester during his term of office shall be at least a first semester junior with the minimum of credits to be considered as such, and the Vice-President shall be at least a second semester sophomore.

3. In the event of the inability of the President to discharge the powers and duties of his office, the same shall

devolve on the Vice-President.

Section II

1. The Student Association President, before taking

office shall take the following oath of office:

I do solemnly swear (or affirm) that I will faithfully execute the Office of President of the Student Association, and will, to the best of my ability, preserve, protect, and defend the constitution of the Student Association of the State University of New York College at Oswego.

Section III

The duties of the Student Association President shall include:

1. The presentation of a legislative program to the Senate at the first Senate meeting following his election and at the beginning of each semester;

2. The appointment, with the consent of the Senate, of all the officers whose appointment shall not be otherwise provided for;

3. The presentation of periodic messages upon the State of the Student Association to the Senate;

4. The execution of all legislation of the Senate for which he shall be responsible to the Senate, except where a specific executive department shall be given authority, in which case the appropriate executive head shall be responsible to the Senate.

Section IV

The Student Association President shall be empowered to:

- 1. Require the opinion in writing of the principle officer of any executive department upon any subject relating to the department;
- 2. Convene such special sessions of the Senate as he shall deem necessary;

3. Recommend to the Senate such measures as he shall deem necessary and expedient;

- 4. Enter into agreements with agencies and organizations outside the college community by and with the consent of the Senate and the proper college authorities:
- of the Senate and the proper college authorities; Represent the Student Association personally, and through his appointed representatives, in all its dealings with agencies and organizations outside the college community;
- 6. Assume such other executive powers as shall not be denied by the policies of the State University of New York or the State University of New York College at Oswego, or by this constitution.

ARTICLE III

Section I

The judicial power shall be vested in a Supreme Court and such lower courts as the Senate shall establish. The number and manner of selection of justices of the Supreme and lower courts shall be determined by the Senate and the appointments of the justices of the Supreme and lower courts shall require approval by a 2/3's vote of the Senate. The term of office of the justices of the lower courts shall be for one year. Justices of the Supreme Court shall serve from the time of their appointment until they shall vacate their office by resignation or otherwise.

Section II

The Senate shall establish such administrative offices as it shall deem necessary for the operation of the Supreme and lower courts and the Supreme Court shall appellate jurisdiction over any lower court created by the Senate.

Section III

The judicial power shall extend:

- 1. To all cases to which the Student Association shall be a party except as otherwise stated in the following parts of this section.
- 2. To the student approval of all local student organization constitutions.
- 3. To any case involving the constitutionality of an act or ruling of the Student Association.
- 4. To any case involving violation of an act of the Senate except as otherwise stated in the following parts of this section.
- 5. To any dispute between students, or between a student organization and a student, or between student organizations, if no lower court, housing unit court, executive committee or commission, judicial board, or standards committee shall have prior jurisdiction, in which case the Supreme Court shall have the power to decide whether the trial or hearing was conducted properly with the power to remand such cases back to the original trial body.
- 6. And to any other case where jurisdiction shall not be denied by the policies of the State University of New York or the State University of New York College at Oswego.

ARTICLE IV

This Constitution may be amended in the following manner: Upon the signing of a petition by 25% of the number of voters in the previous All-Campus Election, or by a 2/3 s vote of all the members of the Senate, an amendment may be presented to the Student Association within two weeks after the presentation

of the petition, in the case of such a presentation, to be accepted or rejected, and if accepted shall be valid to all intents and purposes as part of this constitution.

ARTICLE V

l. All engagements with organizations or agencies outside of or within the college shall be as valid against the Student Association under this constitution, as under the Associated

Student Body Council.

2. This constitution, and the laws of the Student Association which shall be made in pursuance thereof, and all engagements entered into, or which shall be entered into, under the authority of the Student Association shall be the supreme law of student life at the State University of New York College at Oswego except where they may conflict with the policies or practices of the State University of New York or the State University of New York College at Oswego.

3. The Senators before mentioned and all executive and judicial officers, of the Student Association, shall be bound

by oath or affirmation to support this constitution.

ARTICLE VI

The ratification of this constitution shall be determined by at least a quorum vote of the Associated Student Body as established under the constitution of the Associated Student Body Council.

ARTICLE VII

This constitution shall take affect immediately and shall be implemented by the present Associated Student Body Council until May 1, 1966, at which time the new Senators, Student Association President and Vice-President, and other civil officials shall assume the powers and duties of their respective offices, and at which time this article shall be expunged.

BY-LAWS

L. A living center shall be defined for the purposes of Senate apportionment to one of four categories as follows:
(a) on-campus residence halls, (b) off-campus residence units recognized as residence halls by the college, (c) fraternity and sorority houses, and (d) commuters (all students not residing in living centers categorized by a, b, or c above.) The Senate shall determine each year the groupings of the several living centers for the purposes of apportionment and enumeration of Senators to be elected by those groups of living centers.

Permanent speaking seats shall be awarded to:
(a) A representative of the Office of the Dean of Students

(b) A representative of the Office of the Co-ordinator of Student Activities

(c) The executive heads of C.U.B.M., A.W.S., and Athletic Council

(d) And to the delegated representative of any organization which the Senate shall designate by a majority vote.

The legislative session shall be one (1) year in length and shall begin on the first day of May in one year and end on the last day of April of the following year.

4. All meetings of the Senate shall be conducted by

Roberts' Rules of Order.
5. Civil officials shall be

a. President and Vice-President of the Student Association

b. Senators of the Student Association

c. Justices of the Supreme and lower courts

d. Chairman and members of the various departments and the committees of the Student Association Executive and Judicial branches.

A Senator or a Justice at his own discretion may choose to participate in any of the various departments and committees of the Executive branch of the Student Association for the purpose of aiding him in discharging the duties of his office.

7. These by-laws may be amended by a 2/3 s vote of all the members of the Senate. All by-laws to this constitution shall be subject to interpretation as bills under the provisions of Article I, Section 9 of the constitution.

Bill 1

AN ACT

To establish the bill form of the State University of New York College at Oswego for the Student Association Senate.

Be it enacted of the Senate of Student Association of the State University of New York College at Oswego:

I. Purpose

This bill form is the standard bill form to be used at all Senate meetings henceforth for the purpose of maintaining procedure for the passing of legislation.

II. Form

The form to be used is that which is given on the following page. It shall then be entered on the page preceding this bill in the Journal of the Senate.

III. Modification

This form of bill will be so modified so as to include at the decision of the Senate at the end of any bill to come before the Senate enumeration of a roll call vote such as to include the names of the Senators and their votes.

- 2. Countersign all vouchers in cooperation with the advisor to CUB of M. (The vouchers will have first been signed by the student official of the specific committee of CUB of M which is responsible for the expenditures itemized on the voucher.)
- B. Auditing will be done under the guidance of the Development Association. Books will be kept in the Development Association and by the CUB of M Treasurer. To facilitate auditing, copies of the final budget should be presented to the Development Association and also kept on file in the office of the Student Association Treasurer.
- C. The books of SUB of M will be open to inspection by the Student Association Department of Finance at all times. This inspection will not hamper the processing of vouchers of the CUB of M.
- D. The Student Association will not assume responsibility to pay any deficit incurred by the CUB of M.

III. Continuance and Revision

- A. The fee will remain constant until change is initiated. Any change in this fee will be reviewed by the Department of Finance and then will be presented to the Senate for final approval.
- B. Policies governing the expenditure of these funds will be determined by the CUB of M with the approval of the Department of Finance.
- C. These rules and procedures will be effective as of July 1, 1966. They are subject to review at the end of one year period by a joint Student Association and CUB of M committee.

Bill 5

AN ACT

To Establish a Department of Faculty Committees and Academic Affairs

Be it enacted of the Senate of the Student Association of the State University of New York College at Oswego:

(Bill 5 Continued)

I. Purpose

- A. To generally promote and help coordinate the joint efforts of students and faculty in governing the college community of the State University of New York College at Oswego.
- B. To endeavor to maintain and enhance student involvement in the councils, committees, and boards of the College Assembly and other such faculty commissions for the betterment of the college community.
- C. To generally promote in its dealings with students and faculty the continuance of healthy and beneficial student-faculty relations and an atmosphere of trust and cooperation among the students, faculty and administration of the college in the attainment of the goals thereof.
- D. To maintain subdepartments and/or committees as designated by the Senate and in the following sections of this bill to administer these programs, academic or honors in nature, which may be the responsibility of the Student Association.

II. Powers and Duties

E

- A. Present to the appropriate faculty councils, committees, boards, or commissions such recommendations in pursuance of the above stated purpose which it deems necessary or which shall be proposed by the President and/or the Senate.
- B. Recommend measures to the President to be presented to the college administration regarding matters which may be related to the above stated purposes.
- C. Recommend measures to the President to be presented for the approval of the Senate regarding policies and structure of this department and matters which may be related to the above stated purposes.
- D. Establish student committees parallel to existing faculty councils, committees, or boards which it deems necessary.
- E. Maintain committees within this department to administer the following programs, academic and honors in nature:
 - 1. Selections for Who's Who Among Students In American Colleges and Universities.
 - 2. Spring Honors Convocation.

(Bill 5, Section 2, Continued)

- 3. Room scholarships for needy and descrving freshmen entering the college (ten scholar-ships for room rent for a full year in a campus resident hall.)
- 4. Other such programs designated or established by the Senate.
- F. Delegate the administration of programs listed under Section II, Part E, above to honor societies, service organizations, or other such groups on the campus with approval of the Senate. These groups would be responsible to this department, however, in the administering of such programs.

III. Membership

- A. The members of this department shall be:
 - 1. The Chairman of the Department of Faculty Committees and Academic Affairs.
 - 2. Student representatives on faculty commissions.
 - 3. Chairmen and members of committees within the department (except the chairmen and members of groups described in Section II, Part F.)
- B. The President shall appoint each year with the approval of the Senate:
 - 1. The chairman of the Department of Faculty Committees and Academic Affairs.
 - 2. Student representatives to faculty commissions.
 - 3. Chairmen of committees within the departments (except the chairmen of groups described in Section II, Part F.)

AN ACT

To Establish Department of National and International Affairs

(Bill 6 Continued)

Be it enacted of the Senate of the Student Association of the State University of New York College at Oswego:

I. Purpose

In recognition of the need for international understanding and involvement in the society and current affairs of the nation and the world, the Department of National and International Affairs is established for the purpose of:

- A. Providing information for and encouraging study and travel abroad.
- B. Encouraging interest and involvement in national and international affairs.
- C. Aiding forcign students in understanding the American people and culture and helping them to adjust to and take part in our campus community.
- D. Working in cooperation with student organizations and college officials to provide an organized campus-wide program for the fulfillment of the above stated goals.

II. Powers and Duties

- Λ. Provide an information service for students of Oswego regarding programs available for study and travel abroad.
- B. Provide an information service for students regarding national and international affairs of the day.
- C. Establish and maintain each year a program of lectures, discussions and other activities concerning a particular topic of national and/or international affairs. In this endeavor the Department may work independently of and/or in cooperation with organizations and agencies of the Student body and the college.
- D. Establish and maintain a committee the powers and duties of which shall be as follows:
 - 1. Award six scholarships each year at a maximum of \$1,000.00 each to foreign students at Oswego in cooperation with the appropriate college officials.
 - 2. Arrange for talks and discussions during which foreign students may meet and talk with one another and other members of the college community. In this endeavor the committee may work independently and/or in cooperation

(Bill 6, Section II, Continued)

- D. 2. with organizations and agencies of the (Con't.) student body and the college.
 - 3. Make other efforts in fulfilling the purposes of the Department of National and International Affairs in relation to the Oswego foreign students which it may deem necessary and in cooperation with student organizations and college officials.
 - E. Keep abreast of statements and proposals which may be beneficial in furthering the goals of international education and understanding in the nation, the State University of New York, and the State University of New York College at Oswego.

III. Membership

- A. The members of this Department shall be:
 - 1. The Chairman of the Department of National and International Affairs.
 - 2. The Chairmon and members of committees within the Department. The membership of this Department shall be unlimited in number.
- B. The President shall appoint each year the Chairman of the Department of National and International Affairs and Chairmen of committees within the Department.
- C. The Chairman of the Department and the Chairman of the Committee on Foreign Students shall be appointed with the approval of the Senate.

AN ACT

To Establish Department of the Arts

Be it enacted of the Senate of the Student Association of the State University of New York College at Oswego:

- I. Arts Committees
 - A. Within the Department of the Arts shall be the following student-faculty arts committees:

(Bill 7, Section 1 Continued)

- Art Exhibition Committee
- Concert-Assembly Committee
- Festival of the Arts Committee
- Sheldon Lccture Series Committee
- The functions, structures, and procedures of those committees shall remain the same as under the Associated Student Body Council except for the addition of student Vice-Chairmon for those having faculty Chairmen.

II. Membership

- The members of this Department shall be:
 - Chairman of the Department of the Arts 1.
 - Campus Coordinator of Cultural Activities
 - Chairman of Art Exhibition Committee
 - Advisor to Art Exhibition Committee
 - Chairman of Concert-Assembly Committee Vice-Chairman of Festival of the Arts
 - 6.
 - Chairman of Festival of the Arts
 - Vice-Chairman of Concert-Assembly Committee
 - Chairman of Sholdon Lecture Series 9.
 - Vice-Chairman of Sheldon Lecture Series 10.
- B. Ex-officio members shall be:
 - President of the Student Association
 - Dean of the College
- III. Chairman of the Department of the Arts
 - The Chairman of the Department of the Arts shall be appointed each year with the approval of the Scnate.
 - В. Powers and Dutics
 - It shall be the responsibility of the Chairman of this Department to coordinate the activities of these committees in so far as it may be necessary in providing an arts program with sufficient variety and in the general welfare of the college community.
 - To assist and advise the President and Treasurer of the Student Association each year with the incorportation of the expenses of these committees into the Student Association budget for the coming year.
 - To assist in seeking and maintaining an active student membership on the arts committees.

- 4. To maintain communications between the arts committees and the other departments, branches, and officers of the Student Association as to the activities and plans of these committees.
- 5. To assist the President of the Student Association in proposing revisions in this Department and the arts committees to the Senate and the appropriate college officials after which this section (Section III, Part B, #5) shall be expunged.

To Establish Department of Public Relations and Student Services

To Establish Department of Campus Activities

To Establish a Central Lighting Fund Under the Student Association

I. Purposc

- A. To coordinate the lighting expenses of organization budgets under one central fund under Student Association.
- B. To act as a service committee under Student Association for lighting shows open to the campus of student organizations.

II. Membership

- A. Technical Coordinator
 - 1. Staff member appointed and salaried by the Speech and Theatre Department.
 - 2. Act as a liason between the lighting committee and performing arts organizations.
 - 3. Coordinate schedule for lighting based on Master Calendar.
- B. Student Technical Supervisor
 - 1. Appointed by Technical Coordinator
 - 2. Supervise technical production of performing arts organizations.
 - 3. Train employees.
 - 4. Salaried from Student Association at \$1.50/hour.
- C. Employees and Trainces
 - 1. To be hired through the Financial Aids Office.
 - 2. and/or personal contacts of Technical Coordinator, Student Technical Supervisor, or other employees.
 - 3. To be the working crew, under the Student Technical Supervisor for performing arts shows.
 - 4. To be salaried from Student Association at \$1.25/hour for employee and trainec.

III. Budget Allotment

- A. Maintained under Student Association Budget.
- B. To be composed of the lighting exponses of individual organizations in the performing arts.
- C. To include previous SA allocations for maintainence of carbon are projector.

IV. Responsibilities

- A. Student Association Lighting Committee
 - 1. Will work directly under the Department of Public Relations and Student Services.
 - 2. Rules and regulations for operation will be cstablished by the committee and approved by the chairman of the Department of Public Relations and Student Services.
 - 3. Will not assume the responsibility for additional expenses incurred above a 2% contingency of the projected allotment.
- B. Performing Arts Organizations
 - 1. Must remain within projected allotment for lighting expenses.
 - 2. Must abide by rules and regulations established by the Lighting Committee.
