





Bill #91 of the 8th Legislative Session be amended to read as follows with said amendments to take effect immediately. (Matter in parentheses is old law to be omitted; underlined matter is new law.):

IX. List of Supervisory and Polling Areas

A. Same as in original bill #91.

B. Supervisory areas shall be defined as follows:

To take effect April 11, 1973.

1. ~~Lonis-Moreland~~
2. Cayuga and Seneca
3. Hart and Funnelle
4. Onondaga and Oneida
5. Hewitt Union
6. Lakeside

One supervisor shall be designated for each supervisory area.

XI. Petitions

A. All signatures must come from one's constituency. A person may sign more than one petition.

B. Each petition for Senator must contain at least 50 legible signatures. (Each petition for a campus-wide position must contain at least 250 legible signatures.) Each petition for President or Vice-President must contain 250 legible signatures. Each petition for Representative to Faculty Assembly or Faculty-Student Asscoaiton must contain 75 legible sinatures.

XV. Election

A. Any candidate must receive 10% of the vote for a constituency in order to be considered except in the case where no one has filed a petition for the office or in the case where no candidate has achieved 10% of the vote in which cases the candidate with the greatest vote shall be declared winner. For Senator, a constituency shall be defined as two hundred people from the proper living center. For President and Vice-President, a constituency shall be defined as the total number of students in the Student Association. For this position of representative to the Faculty Assembly or Faculty-Student Association a constituency shall be the same as for President or Vice-President.

B. In the event that two or more candidates for the office of President or Vice-President receive the same number of votes the Senate shall decide the winner with each dormitory residency having one vote and a block of nine commuter votes. In the event that there shall be a number of candidates for Senator in a dormitory residency in excess of the number of available positions who shall all have the same vote, the position(s) shall be filled by the same manner as provided for in the Constitution when a Senator shall have resigned his seat. In the event that there shall be a number of candidates for Senator from among the commuter body in excess of the number of available positions who shall all have the same vote, the position(s) shall be filled by a re-vote, of the constituency from among those candidates with the same vote, said re-vote to be held on May 2 immediately following the All Campus Election, or in the event that May 2 shall fall on a Saturday or Sunday, on the first Monday thereafter. In the event that there shall be a number of candidates for the position of Representative to Faculty Assembly or Faculty-Student Association in excess of the number of available positions for either office, the winner (s) shall be chosen from among those candidates with the same vote by the Senate.

Be it enacted by the Student Association Senate of the State University of New York, College of Arts and Sciences at Oswego that:

Amendment to By-Laws of the Oswego Student Association:

(1). This association is not organized for profit nor for the pecuniary gain of its members, officers, or other private persons. It may not issue stock or declare or distribute dividends. No part of the income of the association shall inure to the benefit of any member, officer, or other person, except it may pay reasonable compensation for services rendered in effecting one or more of the association's purposes, and no member, officer, or other person shall be entitled to share in the distribution of any of the association assets on dissolution of the association. Any balance of money or assets remaining after the full payment of association obligations shall be directed exclusively to the furtherance of educational purposes.

(2). Upon the dissolution of the association, the members, after payment or making provision for the payment of the just debts, obligations and liabilities of the association, will dispose of all of its assets by transfer to such other not-for-profit organizations, or organizations organized and operated exclusively for educational purposes, or such other purposes as shall at that time qualify for exemption under Sec. 501-C (3) of the Internal Revenue Code and Sec. 420 of the New York Real Property Tax Law as, in the judgment of the members, is best qualified and competent to promote the purposes of the association.

(3). No part of the activities of the association shall be carrying on propaganda, or otherwise attempting to influence legislation or participating in, or intervening in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.



Be it resolved by the Student Association Senate of the State University of New York, College of Arts and Sciences at Oswego that:

Whereas, the Senate recognize the following:

- 1) The President of the United States is carrying on an illegal and immoral war against the people of VietNam, Cambodia, and Laos;
- 2) The President of the United States has ignored the needs of students and youth across the United States by these actions:
 - a) Ignoring the Scranton Commission on Campus Disorders to impanel a federal grand jury to investigate the murders of students in 1970 by Ohio and Mississippi authorities;
 - b) Ignoring the Presidential Commission on Marijuana which urged decriminilization of marijuana;
 - c) Vetoing repeatedly Health, Education and Welfare Appropriation bills; and
 - d) Vetoing the Water Pollution Control Act of 1972 which will affect our lives in the future.

Be it further recognized that:

The Student Association Senate of the State University College of Arts and Sciences at Oswego endorses the candidacy of Senator George S. McGovern of South Dakota for Presidency of the United States.
